

CHAPTER 89

SHIPS, BOATS AND FLOATING STRUCTURES

NOTE

- 1.- A hull, an unfinished or incomplete vessel, assembled, unassembled or disassembled, or a complete vessel unassembled or disassembled, is to be classified in heading 89.06 if it does not have the essential character of a vessel of a particular kind.

Additional Note

For the purposes of this Chapter, the expression “sea-going” shall be taken to apply only to vessels designed as sea-going, having a hull of an overall length (excluding any projecting parts) of not less than 12 m.

However, fishing boats, lifeboats and floating docks, designed as sea-going, shall be considered as sea-going vessels regardless of their length.
