

CHAPTER 87

VEHICLES OTHER THAN RAILWAY OR TRAMWAY ROLLING-STOCK, AND PARTS AND ACCESSORIES THEREOF

Notes

- 1.- This Chapter does not cover railway or tramway rolling-stock designed solely for running on rails.
- 2.- For the purposes of this Chapter, “tractors” means vehicles constructed essentially for hauling or pushing another vehicle, appliance or load, whether or not they contain subsidiary provision for the transport, in connection with the main use of the tractor, of tools, seeds, fertilizers or other goods.
Machines and working tools designed for fitting to tractors of heading 87.01 as interchangeable equipment remain classified in their respective headings even if presented with the tractor, and whether or not mounted on it.
- 3.- Motor chassis fitted with cabs fall in headings 87.02 to 87.04, and not in heading 87.06.
- 4.- Heading 87.12 includes all children’s bicycles. Other children’s cycles fall in heading 95.01.

Additional Notes

- 1.- For the purposes of this Chapter, the expression “C.K.D.” when it applies to motor vehicles (other than “economical cars” and “light economical utility vehicles”) does not cover the components and parts listed hereunder, which are classified according to kind:

1. (2)¹ I) For the purposes of this Chapter, the expression “C.K.D” does not cover the following parts:

- Mounted cabs for motor vehicles for the transport of goods
- Mounted chassis for vehicles for the transport of goods and vehicles for the transport of persons

II) Cabs and chassis of C.K.D. vehicles for the transport of goods or of persons must be disassembled as follows:

A. For motor vehicles for the transport of goods:

a) Parts of cabs:

1. The front panel
2. The back panel
3. The left door opening
4. The right door opening
5. Roof panel
6. Front left door
7. Front right door
8. The floor

b) Chassis parts:

1. The right side member
2. The left side member
3. Cross beams
4. Spring holders

B. Chassis parts for vehicles for the transport of persons:

1. The right side member
2. The left side member
3. Cross beams
4. Spring holders

2.- For the purposes of this Chapter, the expression "C.K.D." when it applies to motorcycles (or mopeds) (other than "economical mopeds" or cycles fitted with an auxiliary motor, of a cylinder capacity not exceeding 50 cc) does not cover the components and parts listed hereunder, which are classified according to kind:

- Saddles
- Wheel rims
- Spokes and nuts therefor
- Handlebars
- Tyres and inner tubes
- Engines, including engines for "economical mopeds" – Steering sets
- Shock-absorbers
- Saddle rods
- Forks
- Mudguard connecting rods
- Exhausts
- Stands
- Cables and sheathes

3.- For the purposes of this Chapter:

a) Subject to the conditions of paragraph b) of this note (defining used agricultural tractors) , are considered as new vehicles; vehicles

- have not received a first entry into service authorization and vehicle registration certificate; or
- have received a first entry into service authorization in the originating country, valid 90 days or less, even registered.

If the vehicle is not covered by such certificate, it should have a certificate of identification or fitness, issued by the manufacturer or his representative in Morocco, listing its technical specifications and date of manufacture.

4.- Subdivisions 8703.21.41.00 and 8703.21.49.00 do not cover new or used “cross-country carts” which do not comply with the following specifications and are imported assembled:

- Tubular chassis and structure;
- Two driving wheels;
- Double pantograph front suspension (2 shock-absorbers) and back suspension (4 shock-absorbers);
- Spark-ignition engine, whether or not reconditioned, of a cylinder capacity of less than 1 000 cc, without hood;
- Non-adjustable seats;
- Turning radius: 2.40 m;
- Overall length: not exceeding 2.65 m;
- Overall width: 1.60 m;
- Overall height: 1.20 m;
- No coachwork (basic roof);
- No real doors (side nets);
- No windows (windscreen replaced by a spray net);
- No boot (trunk);
- Wheels with no mudguards;
- Maximum speed: 90 km/h.

5. Subdivisions 8703.21.61.00 and 8703.21.69.00 cover only new or used “carts” which comply with the following specifications, imported unassembled or disassembled:

- Tubular structures;
- No suspension;
- One or two single-cylinder spark-ignition engine(s) of a cylinder capacity not exceeding 500 cc, whether or not equipped with gear boxes
- Back wheel chain or belt transmission;
- Steering (column with two small swivel arms);

- No reverse gear;
- Seat, whether or no adjustable;
- Overall length: not exceeding 2 m;
- Overall width: not exceeding 1.5 m;
- Overall height: not exceeding 0.7 m;
- No windows;
- No boot (trunk);
- Maximum speed: 130 km/h.

6- In this chapter vehicle with hybride technology means, vehicles with hybrid motorization . These vehicles combined an internal combustion engine and one or more electrics motors and accumalators.

The electric (s) motor (s) will act in two situation: Either in support of the internal combustion engine to give more power to the vehicle, or only at low speed, allowing the internal combustion engine to remain extinct.
